### President's Message

An exciting year is ahead for school psychologists in Texas! There are so many changes and controversies in our field right now, one could become easily overwhelmed. However, with change and controversy, comes opportunity. TASP is poised to make a significant



contribution to the shape of school psychology practice in the future, not just here in Texas, but on the national level as well.

As you know, there are a number of threats to the practice of school psychology as we know it. In Texas, LSSPs are currently being sanctioned for using the NCSP. This credential, ironically, is the minimum standard for licensure eligibility for the LSSP. However, TSBEP has interpreted Texas law as prohibiting LSSPs (who are not dually licensed as LPs) from including the NCSP in their signature block, business card, name tag, etc. TASP absolutely disagrees with this prohibition and is seeking all possible avenues to address this ruling.

On the national level, the Model Licensure Act from APA was adopted by the APA Council of Representatives was approved in February. There were significant last minute negotiations and machinations and language was included that recognized that most school psychologists are credentialed by state education agencies and that the MLA was not intended to restrict the regulations of state education agencies. While this language is much less broad than the previous outright exemption for school psychologists, this is a victory indeed. How does this affect me? We already operate under such a prohibition in Texas? One way this is important to school psychologists in Texas is that Texas is being presented as an example of how the restriction of the use of the title school psychologist does not have any negative impact. Anyone who has attended a meeting of TSBEP will certainly beg to differ with that opinion. While the conditions of use of the title of school psychologist in the MLA may not affect the day to day practice in the schools of most school psychologists in Texas, the impact on the profession is real, including the restriction of the use of the NCSP.

Many of you may be thinking, "I am so tired of hearing about this, this has nothing to do with me, I just go to work and help kids everyday...." That brings me to an important part of my message: TASP is committed to





### **GPR Update**

I am so glad to be GPR for TASP this year and doubly pleased that our previous GPR, Kelly Anderson, is going to co-chair this role with me. Her experience will be invaluable.



Even though we are in a non-legislative year, TASP already has several things working on the GPR front. First, we continue to work closely with NASP on the issue of our NCSP here in Texas. NASP has been very supportive of Texas LSSPs and they offered great guidance to TASP in addressing our local concerns. I hope to learn more about that at the NASP Convention in Chicago in March.

Second, TASP was contacted by one of our members (a Psy.D.) who was applying to TSBEP to be a Provisionally Licensed Psychologist (PLP). As a side note to his application, a TSBEP representative told him that he should only be using his PLP while he was under supervision, even though he was a fully licensed LSSP and working in a Texas school district in that capacity. He shared this with TASP and the TASP Board sent a letter to TSBEP on his behalf disagreeing with the opinion. I attended the TSBEP meeting with our President and our President-Elect on February 11th. TASP's letter was not addressed.

At this TSBEP Board Meeting, however, there was another letter that raised an identical issue and the Board maintained their opinion that using the LSSP when under supervision for another license was inappropriate. Two of the Board members, who are LSSPs, disagreed with the response letter, but the motion passed. The LSSPs then asked for further investigation into this matter and the rule in question. We will keep our membership informed of any developments.

Public comments were made by two LPAs expressing their desire to be able to practice independently following 5 years of supervision. TSBEP is being forced to make budget cuts in this biennium. They will no longer be printing the Board Rules in paper format and may not be able to offer the rules or the roster of licensees on their website dues to these budget cuts. One of the Public Members of the Board raised concern at these changes and offered to look into cost effective ways to offer more information to licensees online.

Another issue addressed at the TSBEP Board Meeting was the Colleague Assistance Program that TASP and TPA pledged funding for this January. When the agenda item was addressed, the Committee Chair said, "nothing to report". Then, at the very end of the meeting, the Board Chair said that given the current situation with finances and other more pressing concerns, that he did not feel the Colleague Assistance Program was a priority at this time and the process was essentially removed from consideration. Contact has been made with the representative of TPA and a phone conference for the TASP Task Force members involved with this effort has been scheduled.

I urge any LSSPs that can, to attend a TSBEP board meeting or to request a copy of the official transcript. I was disheartened by some of the attitudes toward LSSPs and feel we must be vigilant in protecting our licensure so that we may continue to provide the services that our school children need. The meeting schedule for the rest of this year is as follows: May 6, 2010, August 12, 2010, and October 28, 2010. Meetings are held at the William P. Hobby Jr. Building in downtown Austin and begin at 9:00am.

Finally, TASP hopes to propose legislation in the upcoming year that would resolve the issue of our use of the NCSP. To that end, we are in the process of contacting and interviewing potential legislative liaisons to help us in this matter.

With such an active agenda for this year, we welcome volunteers to the GPR Committee who have an interest in improving the security and status of the LSSP....§

The abstract should be on a separate page and be no more than 150-200 words in length. It should summarize the focus of the work, including its relevance to the field, and provide a synopsis of the proposed content.

### 3. SUMMARY OF THE PROJECT


The summary should be no more than 800 words in length. This section should include a summary of the content and how it will be organized. It should also discuss how the proposed work will contribute to the field, emphasizing its relevance to school psychology. There are many possibilities for presenting the rationale, but it must explain the reasons why this particular work is important. . §

## A cultural tipping point: The Texas School Psychologist is going digital

The newsletter of the Texas Association of School Psychologists is about to undergo a radical change. You are holding one of the last mass printed copies of this newsletter. Beginning this Fall TASP will be disseminating this newsletter electronically and members will no longer receive a printed copy. Why.

There are 3 main reasons.

First is economic. Mailing and printing costs have always been significant, but have been rising. This results in rising membership dues and reduces the organizations abilities to address our core missions. Less money on mailing equals more money on educational and legislative activities.

Second is environmental. This thing you are holding; we went and cut down a tree, transported the tree to the mill, ground it up, made paper, shipped the paper, cut and printed on it, individually addressed and mailed it to a number of people who promptly threw it in the trash, where this thing you are holding is destined. We eliminate that entire energy and resource intensive cycle by going digital.

Third and most importantly is cultural. I have argued against moving away from a printed newsletter as I feel that it is one of our most accessible and powerful recruiting tools. The recruiting element (you should give this to a non-TASP member when you are done reading it) will be lost, and we as an organization will need to address that. I also have argued that many of our members, particularly the older and the more analog among us, did not have ready access to "the interwebs". And that is the cultural tipping point we have reached. The vast majority of you holding this paper have daily access to online resources;

many of you have that access in your pocket right now. We searched the records; there are officially two members without email addresses.

The change to a digital format maintains the core mission of the newsletter: inform our members of current events in our field. It also brings a dynamic element that allows a two way exchange of information and instant links to more detailed information. Most other states have gone electronic according to the NASP Newsletter Editors listserv (sampling bias much?) which gives even more evidence that it's time. If you just can't deal with the loss, we will be providing a print ready version that you can put your coffee on or line your bird cage with.

Next edition, the last in print, will have instructions to ensure you aren't left behind in the transition. Take a good look, you're holding a relic. We've reached a cultural tipping point....§



School Psychology is a changing profession. The scope and levels of service outlined as principles at the National Association of School Psychologist Conference in 2002 are now directional strategies involving the: "improve(ment) of academic competency, social and emotional function, family-school partnerships, classroom instruction, and school-based child and family health services for all learners" (NASP, p. 8).
